依華僑身分證明條例施行細則第18條第2項規定，申請非供役政使用之華僑身分證明書，其委任書：1. 於國外製作者，應經駐外館處驗證。2. 於大陸地區製作者，應經行政院設立或指定之機構或委託之民間團體驗證。3. 於香港或澳門製作者，應經行政院於香港或澳門設立或指定之機構或委託之民間團體驗證。4. 於國內製作者，應經公證人認證。

Remark: According to Article 18, Paragraph 2 of the Enforcement Rules of the Overseas Compatriot Identity Certification Act, for an Overseas Compatriot Identity Certificate issued for the purpose of non-conscription administration, the aforementioned power of attorney for the agent shall handled as follows: 1.If made overseas, it shall be authenticated by the Embassies and Missions abroad; 2.If made in Mainland China, it shall be authenticated by the institutions established or designated, or by the private organizations authorized by the Executive Yuan; 3.If made in Hong Kong or Macao, it shall be authenticated by the institution established or designated, or by the private organizations authorized by the Executive Yuan in Hong Kong or Macao; 4.If made in the R.O.C. (TAIWAN), it shall be notarized by a notary public.
